- The Government of Nepal has received a loan from Asian Development Bank (ADB) towards the cost of Melamchi Water Supply Project and intends to apply part of the proceeds of this loan to eligible payments under the Contract for construction and completion of the **Headworks and Diversion Tunnel** of the project. Bidding is open only to bidders from eligible source countries of the ADB. International Competitive Bidding will be conducted in accordance with <u>ADB's Single-Stage</u>, <u>Two-envelope Bidding Procedure</u>.
- 2. **Melamchi Water Supply Development Board, MWSDB** ("the Employer") invites sealed bids from experienced and eligible bidders, based on post-qualification criteria, for the construction and completion of the Works. The Works comprise the following main activities:
 - a. construction of headworks and intake structures in Melamchi River near Ribarma, Sindhupalchowk,
 - b. permanent support works for already completed tunnel construction works (approximately 6.5 kilometers),
 - c. construction of approximately 21.3 kilometer water diversion tunnel including permanent support works,
 - d. construction of reinforced concrete invert in the water diversion and adit tunnels
 - e. maintenance of access roads to tunnel exit portal at Sundarijal and adits at Ambathan, Gyalthum and Sindhu, and operation and maintenance works of camp facilities and project vehicles,
 - f. construction of access road to headworks including river crossing bridge over Melamchi River.
 - g. other works necessary.
- 3. The main qualification criteria are:
 - a) Minimum average annual construction turnover of <u>US Dollar One Hundred Fifty</u> <u>Million (US\$150,000,000)</u> calculated as total certified payments received for contracts in progress or completed, within the last Three (3) years.
 - b) Participation in at least two construction contracts outside the Bidder's home country within the last 10 years which have been successfully or substantially completed and where the value of the Bidder's participation in each contract is at least US Dollar **Forty Million (US\$40,000,000)**.

- c) Participation in Construction of at least Fifteen (15) km of tunnel of any cross section in 5 or less number of contracts within the last 10 years that are similar to the proposed works and which have been successfully or substantially completed; the similarity of contracts shall be based on the bidder's experience of tunnel construction with drill and blast method using drilling jumbos.
- d) Participation in at least one contract with at least 1 km of tunnel construction with cross section 10-20 m² within the last 10 years which are similar to the proposed works and which have been successfully or substantially completed; the similarity of contracts shall be based on the bidder's experience of tunnel construction with drill and blast method using drilling jumbos.
- e) Construction of shotcrete lining with shotcrete robots in at least 1 contract with at least 1 km length within the last 10 years.
- f) Installation of at least 50 metric tons (MT) hydraulic steel works (similar to items described in Section 6. Employer's Requirements Subsection 16-Hydraulic Steel works) within the last 10 years.

The bidders need to state and establish the availability with certification, plan for buying or renting the suitable equipment required for the project including the planned mobilization schedule of the equipment for timely completion of the works.
